#### **OBJECTIVES:**

- The objective of this checklist is to verify compliance to the Criteria listed in the Sabah Legality Standard as defined by Principles 1 4 for Sabah dated 01<sup>st</sup> January 2015 (FDS-TLAS-002).
- Compliance is defined when all applicable criteria are observed to be compliant. A Minor Gap to any indicator does not constitute non-compliance to a criterion. A Major Gap to any applicable indicator does reflect non-compliance to a criterion. Compliance for a criterion where multiple minor gaps are identified in indicators under the criterion may reflect non-compliance to the criterion.
- All issues identified under this standard shall be considered appropriate to the scale and degree of forestry operations undertaken by the parties under the agreement.

# **Summary Information**

#### Overview of Licensee:

- Anika Desiran Sdn. Bhd. (Anika Desiran) is a Sabah registered company involved in Natural Forest Management and Industrial Tree Plantation (ITP) development within FMU 5, which comprises a total gross area of 88,920 ha.
- Land tenure is based on the Sustainable Forest Management Licence Agreement (SFMLA) 10/1997 commencing on 10<sup>th</sup> September 1997 and expiring on 09<sup>th</sup> September 2097 for all activities within the concession. About 12,241 ha of the licensed area have been excised and classified as Class 1 Protection Forest under Nuluhon Trusmadi Forest Reserve; FMU 10 (Ref.#: JPHTN/KGU (FMU10) 600-1/KLT.2 (109) dated 20 December 2016).
- The previous assessment was conducted in Mar 2017 that resulted in 2 observations (Report #: G161-139).

\*The 3<sup>rd</sup> FMP, was approved by the Chief Conservator of Forests (CCF) on 17 October 2017, which is valid from 1<sup>st</sup> September 2017 to 31<sup>st</sup> August 2027. The licensed area has been divided into two areas, area (A) and Area (B), for ITP and NFM. *Errors were observed in the FMP that list Area A as NFM and Area B as ITP (see Gap 022/2018 (Minor) - checklist 1.4.2).* 

#### **Environmental Context:**

- The FMU 5 is located within the Trus Madi Forest Reserve (a Commercial Class II natural forest), which had been logged several times over the past 36 years from 1970 to 2006. Anika Desiran received the forest license in 1997 but had since carried out very limited harvesting and stopped all logging operations natural forest in 2006, except for 2 ITP Coupe areas where salvage logging operations were implemented until Oct 2015.
- Although the forests are generally described as degraded, a few faunal studies were carried out in the area, which concluded the area still provides reasonable quality habitat for wild boar, sambar deer, barking deer and mouse deer. Gibbons, Clouded Leopards and Orang-utan were also identified in the area. However, there are no signs of endangered mammals such as Elephants or Tembadau occurring in the FMU.
- Areas containing High Conservation Values (HCV) were identified during the preliminary assessments. The approved third FMP describes 11 compartments, which contain HCV attributes (high biological and ecological values: high altitude forest and species, bird nest caves, waterfalls, water catchment areas and graveyards). In 2015, further studies were carried out to verify and finalize the HCV occurrences in the FMU.

- Anika Desiran holds an approved EIA report for its ITP development activities.
- The Director of the Environment Protection Department (EPD) had approved the supplement legality agreement on 20 February 2018.

#### **Social Context:**

A Social Baseline Survey has been conducted in FMU 5:

- Most of the local communities belong to the ethnic group of Dusun. Their villages are accessible by land and river.
- Rubber tree farms, fruit tree orchards and small oil palm plantations form the main economic crops of the local communities. Subsistence farming is also widely practised by the local communities that plant a mix of traditional crops such as hill paddy, tapioca, maize, sweet potatoes, and vegetables. These food-crops for subsistence purposes.
- Local communities who have settled down in the Forest Reserve in the 50s' and 60s' are very concerned with the acquisition of legal rights to land and resources, which they have occupied through native customary rights. The local communities residing outside but cultivating inside the Forest Reserve also make similar claims. Many of them have submitted land applications with the local authorities, without knowing that the areas located within the Forest Reserve.

#### Scope of Assessment

- The scope of the evaluation is to verify compliance of Anika Desiran Sdn. Bhd. with the Sabah Forest Management License Agreement (SFMLA 10/97) for FMU 5.
- The assessment is in accordance on the terms of the agreement for the "Sabah Legality Standard Principles 1 4 dated 01<sup>st</sup> January 2015 **(FDS-TLAS-002)**.
- Site evaluation to verify and report the level of compliance by Anika Desiran Sdn. Bhd. and contractors to the standard in respect to each of the criteria within this report.
- Compliance is defined when the auditee demonstrates that the indicators consist of none or only minor gaps against any applicable criteria of the standard. Non-compliance to the Sabah Legality Standard occurs when the auditee does not demonstrate adequate compliance to a criterion.

### **Highlights of Assessment**

March 2018: (Major Gaps = 3; Minor Gaps = 5; Observations = 2) August 2018: (Major Gaps = 1; Minor Gaps = 4; Observations = 2) January 2019: (Major Gaps = 0; Minor Gaps = 5; Observations = 2)

Anika Desiran Sdn. Bhd. has now complied with the Sabah Legality Standard (**FDS-TLAS-002**) as based on the close out report by FDS on 14 January 2019.

Anika Desiran Sdn. Bhd. closed major Gaps 021/2018; 023/2018; 024/2018; however, Gap 026/2018 was raised to major thus the company did not comply with the Sabah Legality Standard (**FDS-TLAS-002**) as a non-compliance was identified for *Criteria 3.1* following the close out report by SFD on 1 August 2018.

FDS has provided a second close out report (Ref. #: JPHTN/SFM (FLEGT) 800-1/7/7/3/11) dated on 14 January 2019 that detailed activities and findings against Major Gap 02/2018 listed in the report.

#### Summary of status of operations by **Principle**:

#### Principle 1.

**Gap 020/2018 (Minor) – Checklist 1.1.1**: The supplementary agreement for FMU 5 area was not made available during the assessment.

#### March 2018: Gap 021/2018 (Major) - Checklist 2.1.3:

Anika Desiran has not presented Environment Compliance Reports for 2017 and inadequate environment mitigation measures were observed during the assessment.

#### August 2018: Gap 021/2018 (Major) - Closed

Environment Compliance Quarterly Reports were made available by Ekohandal SB for 2017 and all mitigation measures have been fully implemented (Ref.#: JPHTN/SFM/FLEGT) 800-1/7/7/3/10)

#### Gap 022/2018 (Minor) - Checklist 1.4.2:

Forest resource data for long-term management planning are outdated and do not reflect the actual stocking conditions. The Annual Allowable Cut for NFM has not been determined, due to lack of reliable resource data. Observed inconsistent and confusing forest zoning data in the approved 3<sup>rd</sup> FMP.

**Observation 001-2018 – Checklist 1.9.1**: The rationale for selection of the number of PSPs and their locations within the FMU has not been described.

#### Principle 2.

#### March 2018: Gap 023/2018 (Major) - Checklist 2.1.5:

Marking of buffer zones and riparian reserves was not adequately implemented. Riparian areas were observed disturbed by road construction that included direct river access. Identification of steep areas ≥25 in the Compartment Harvesting Plan for Compartment 58 (5.6 ha) differed with the actual ground conditions.

#### August 2018: Gap 023/2018 (Major) - Closed

Buffer zones for all rivers / permanent streams have been marked and warning signage at crossings according to EIA requirements have also been erected. Licensee has blocked the access to the riparian areas and planted native seedling for rehabilitation. (Ref.#: JPHTN/SFM/FLEGT) 800-1/7/7/3/10)

#### March 2018: Gap 24/2018 (Major) - Checklist 2.6.2, 2.6.7, 2.6.10:

No training on safety & health and fire prevention & suppression were conducted for the workers.

#### August 2018: Gap 24/2018 (Major) - Closed

Training on safety & health and fire prevention & suppression have been conducted as required. (Ref.#: (JPHTN/SFM/FLEGT) 800-1/7/7/3/10)

Observation 002-2018 - Checklist 2.1.10: The performance for AWP compliance 2017 scored at 78%.

#### Principle 3.

#### Gap 025/2018 (Minor) - Checklist 3.1.1:

Three heavy machineries were found without FD registration plate number.

#### March 2018: Gap 026/2018 (Minor) - Checklist 3.1.2, 3.1.3:

Royalty payment had been paid to receive the Removal pass. However, the company did not maintain copies of the Royalty Receipts and other payment receipt (Premium, Community Forestry Cess, Forest Conservation Fees Forest Rehabilitation Fees as applicable) in their office.

#### August 2018: GAP 026/2018 (Raised to Major)

Inadequate evidence that the company has made payments for log extraction as many payment receipts were not available in 2017 & 2018 against scaling orders and TDP. Sabah State Government has suspended the concession from operations in July 2018 due to investigation of illegal logging. The investigation by the government needs to be completed and records of production and payment of royalty and associated fees need to be verified.

#### January 2019: GAP 026/2018 (Raised to Major) - Closed

The company has provided a complete set of royalty payment receipts, scaling orders and TDP's to the royalty paid logs from October 2017 to March 2018 (Ref. #: JPHTN/SFM(FLEGT) 800-1/7/7/3/11 dated 14 January 2019).

#### January 2019: GAP 028/2019 (Minor) - Checklist 3.1.3

Logs transported to their clients were accompanied with FDS Removal Pass. However, payment receipts for the removal passes were not available during the assessment.

#### Gap 027/2018 (Minor) - Checklist 4.1.4:

Anika Desiran did not conduct any community consultation meetings in 2017.

Gap 020/2018 (Minor) - Checklist 1.1.1: The company shall keep a copy of the supplementary agreement at their office.

#### Gap 022/2018 (Minor) - Checklist 1.4.2:

- Anika Desiran needs to amend the FMP in respect to the correct area information for Natural Forest Management and Plantation areas.
- To carry out systematic forest resource assessment, covering the whole NFM net production area.
   Number of sampling units to be based on the statistical variance of live basal area or standing gross timber volume.
- To provide a credible estimate of growth and yield projection to form an Annual Allowable Cut.

**Gap 025/2018 (Minor) – Checklist 3.1.1:** To ensure that all vehicles and machineries operated by the harvesting contractors are furnished with FD registration plates.

**Gap 027/2018 (Minor) – Checklist 4.1.4:** The licensee shall ensure communication with communities in regards to operations and to discuss concerns of the communities.

**Gap 028/2019 (Minor) – Checklist 3.1.3:** The company shall maintain the FDS Removal Pass payment receipts in the office.

**Observation 001-2018 – Checklist 1.9.1:** The company shall establish Permanent Sample Plots (PSP), to measure forest conditions and growth of residual stands. PSPs need to be established prior to harvesting to evaluate damage and regrowth of the residual stands.
