Non-compliance must be formally addressed prior to certification or within 2 months following a surveillance assessment.

Recommendations

Samawang Sawmill Sdn. Bhd. has demonstrated compliance with the Sabah Standard Principles 5-6 for Chain of Custody and is recommended to receive a GFS Audit Statement and STCC from FDS.

Gap identified in this assessment should be addressed before the next surveillance visit. Action required to close the gap includes:

Gap 004/2019 (minor) – Checklist 5.2.1: Samawang Sawmill shall ensure Sabah TLAS and non-Sabah TLAS logs are physically segregated. An internal training for workers at the log pond needs to be conducted to increase awareness on the implementation of segregation of Sabah TLAS material.

The next surveillance visit will be scheduled in March 2020.
