Ta Ann Plywood has received a Statement of Participation in September 2013 for the GFS WTP based on compliance with GFS chain of custody standard GFS-WI-006-WTP.3 Ta Ann Plywood was recognized to be able to trade **Verified Legal (VL)** timber products that the company produced and traded. This exercise involves surveillance of their office and mill records base in Sibu, Sarawak. Sales markets include to Japan, Taiwan, India, Hong Kong, Korea, Singapore and Australia.
